



ANNEX A: MEDEVAC Procedures



In accordance with the VIRginia International Raceway (VIR) Range Operations Standard Operating Procedure (SOP), the following will serve as a guide in the event of a range emergency. VIR EMS is not required to be on station for range operations when supplemented by a qualified and identified Range Medic is on site for the duration of training. For any training that does not exactly specify that EMS be on station, R.F.H Tactical Mobility LLC (RFH TM) will utilize our highly qualified TCCC, combat-experienced medics with support from the local 911 system.

1. All driver and firearm training will be conducted with a VIR Motorola handheld radio tuned in to **channel 2** or **434-822-3101**. VIR EMS monitors this channel Monday through Friday 8am to 5pm EST. EMS call sign is “EMS”; Range call sign: “Range #” Safety vehicles with a medical kit shall be designated and in place prior to any training on VIR. Channel 2 is a repeated channel so there is a delay in transmission. In the case that VIR EMS is not utilized, all communications are routed directly through the RFH TM training headquarters and chain of command.

2. If training is to be conducted on weekends or weekday evenings, local first responder units are notified in advance in order to ensure they are aware of the training to best be prepared in case of emergency during those hours.

3. - When using VIR EMS - If a medical emergency occurs and the patient is not moveable, immediately contact and dispatch VIR EMS to your location. Provide on-site medical care until EMS arrives.

4. - When using VIR EMS - If a medical emergency occurs and the patient is moveable, immediately place the victim in a safety vehicle and transport them to the North Paddock EMS location. While enroute to the North Paddock EMS location, notify EMS of your emergency situation.

5. If life threatening injuries are present on an individual and VIR EMS is unable to provide adequate care, contact **Duke Medical Center Life Flight**:

Baptist Aircare has a MEDEVAC helicopter stationed in Martinsville, VA and normally can get here quicker than Duke Life Flight and they will transport you to whichever hospital you want to go to. Baptist also works with the track during racing events and are familiar with the facility and designated HLZ's.

“This is **your name** at Virginia International Raceway. We have an individual with life threatening injuries. The victim will not live if we transport him/her by ground. We are requesting life flight services at the following coordinates **36° 33” 94’ -- 79° 12” 41’**

•**ETA:** Aprox 15 minutes

•**VIR HLZ:** vehicle skid pad located near the pavilion heading into the North Paddock

Directions to Danville Regional Medical Center (Level 2 Trauma Center) Total 15.2 miles (30 min)

- Depart VIR front gate
- Turn right at stop sign – drive .5 miles
- Turn right at stop sign (HWY 57) Drive 5 miles
- Turn left at stop light (US 58) Drive 7.1 miles
- Turn left onto Main St. drive 1.2 miles
- Keep left .2 miles
- Destination is on your right

Directions to Person Memorial Hospital (Level 2 Trauma Center) Total 19.7 miles (34 min)

- Depart VIR front gate
- At stop sign, continue straight – drive .5 miles
- Turn left at stop sign (HWY 57) Drive 16.5 miles
- Turn left at stop light on to S. Morgan St – drive .7 miles
- Turn left at stop light on to Reams Ave. – drive .3 miles
- At end of road turn right on to Ridge Rd. – drive .5 miles
- Destination is on your left
